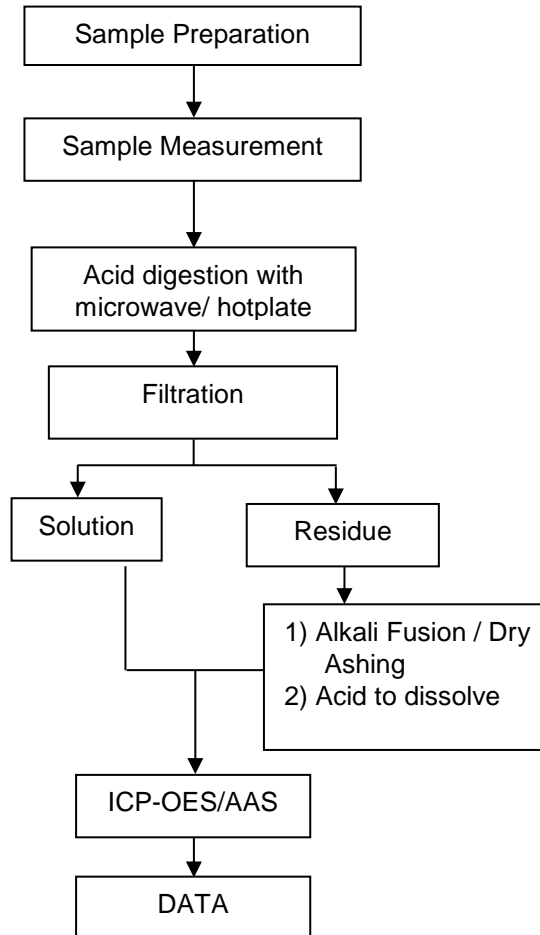

Elements Testing Flow Chart

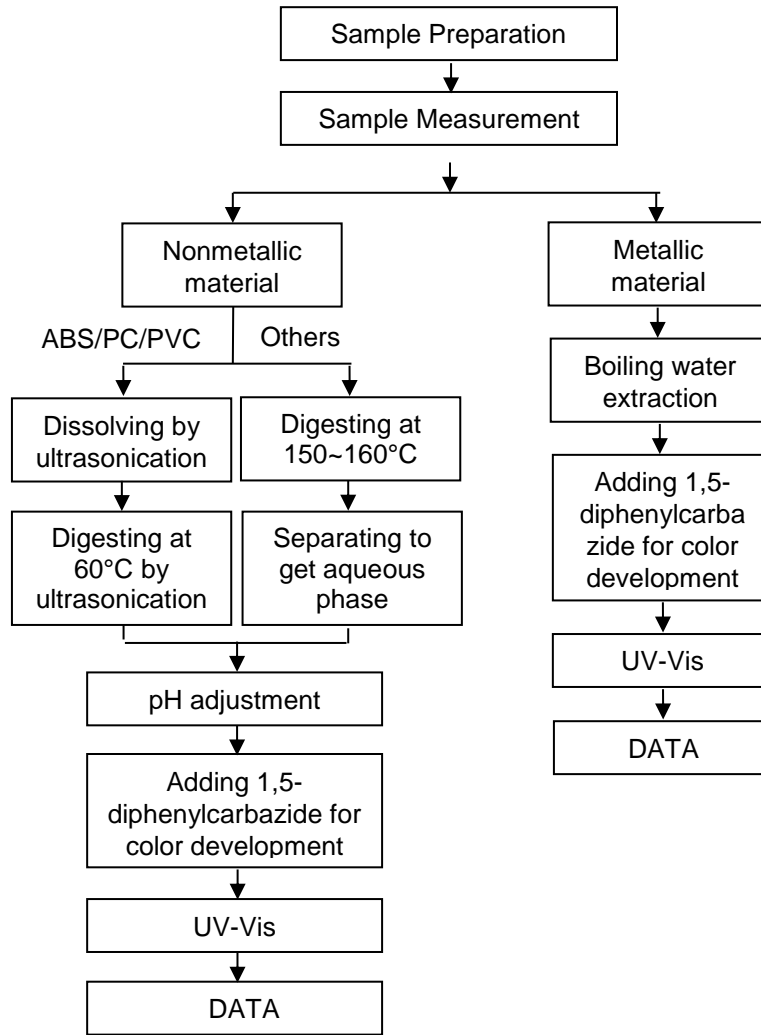

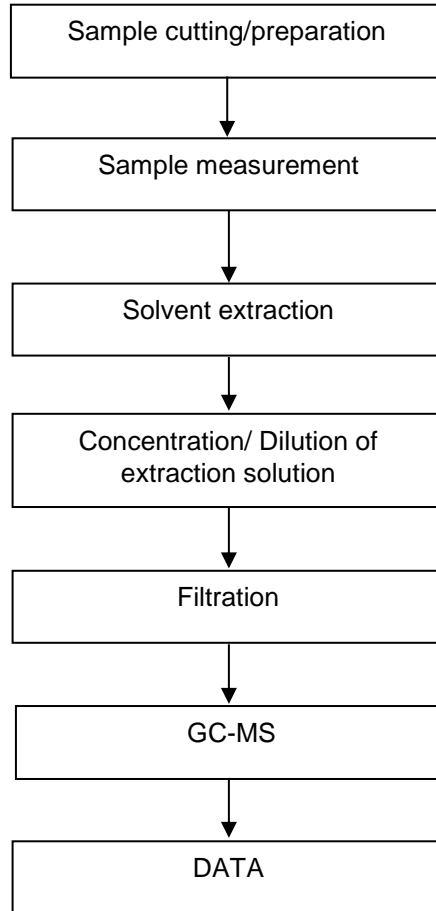

Hexavalent Chromium (Cr(VI)) Testing Flow Chart



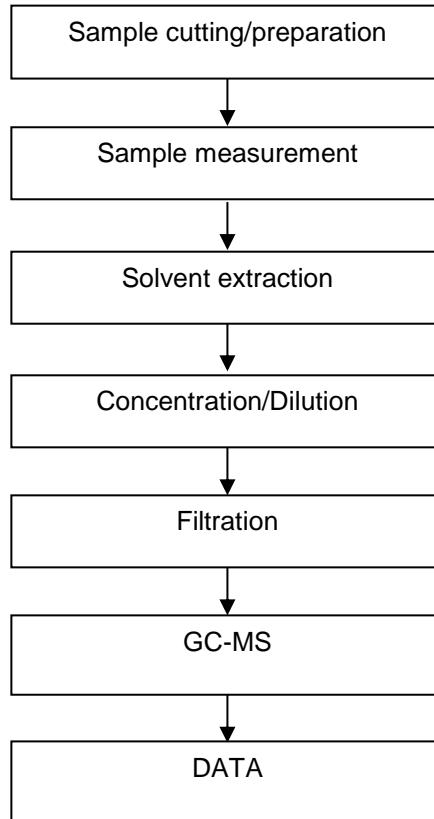
PBB/PBDE Testing Flow Chart

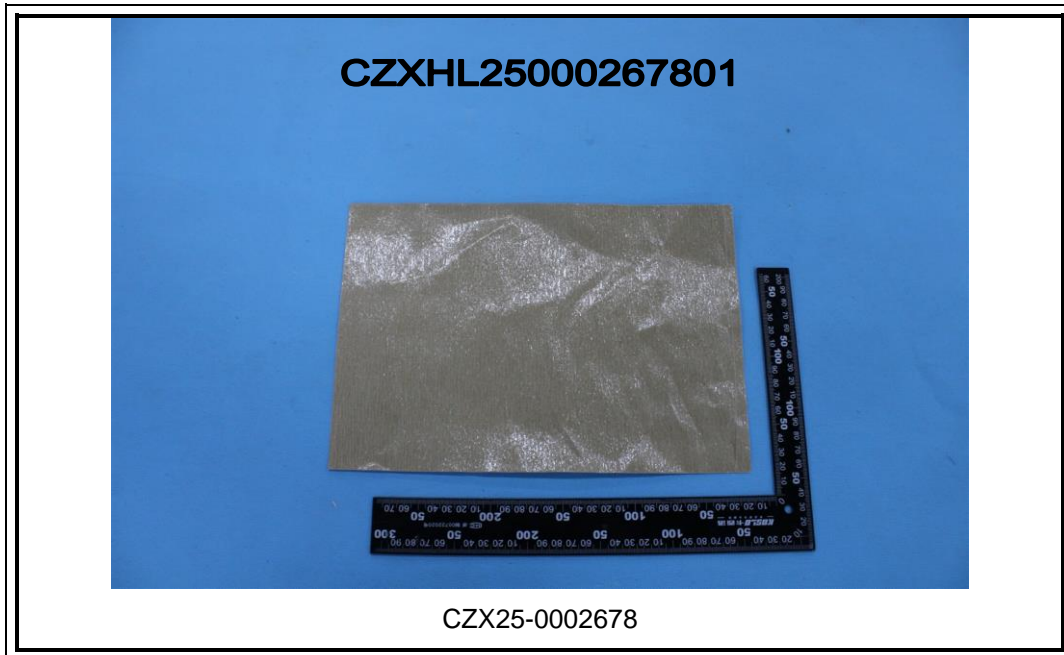
